## CONDITIONS OF SALE

### FROST

All plastic parts of the irrigation system supplied directly by Royce Turf & Irrigation are guaranteed against frost damage for a period of one year from date of purchase. Manifolds and other galvanized parts must be drained of water in the winter months as these are not guaranteed against frost damage. Lever valves should be left in the open position and electrically controlled solenoids should be manually opened and left open for the duration of the frost hazard.

### DEFECTS

All parts of the irrigation system supplied by Royce Turf & Irrigation are guaranteed for one year against material or manufacturing defect. This excludes pump station equipment which is covered under a separate manufacturers guarantee.

All equipment supplied by Royce Turf & Irrigation is robust and can withstand normal handling however it is possible to damage the polyethylene pipe and fittings by accident (by spade, edge cutter and motor mower for example). Royce Turf & Irrigation does not hold itself responsible for such damage to the system but we take every precaution to minimize the chance of damage by laying pipe in a visible position within beds and burying it under grass and pathways where necessary. In addition we supply each customer with a DIY repair kit containing sufficient spares to maintain the system.

### DISTURBANCE OF PLANTS

During the course of the installation it is necessary to move in and around flower beds and borders and occasionally to trench through lawns and under pathways. While Royce Turf Supplies and Irrigation makes every effort to leave the site as it was found the company does not hold itself responsible for any disturbance to plants and lawns.

### LICENSES AND PERMITS

It is the clients' responsibility to obtain all necessary licenses and permits for the use of mains water or the abstraction of water from any other source, prior to the installation of the irrigation system.

### V.A.T.

All prices referred to in the quotation exclude V.A.T. This is calculated at the prevailing rate and will be added to the final total price.

### PAYMENT

For all contracts of less than a £1000.00 Royce Turf Supplies & Irrigation expects payment immediately upon completion of the work agreed on.

For all contracts of more than a £1000.00 Royce Turf Supplies & Irrigation expects payment of one third of the total as a deposit before work commences, one third payment mid-way through the project and the balance on completion of project. Title of goods does not pass to the client until paid in full.

### ESTIMATES

Estimates are valid for 30 days.

Quotations are valid for 30 days unless stated otherwise on the quotation letter. Where there are variations a further quotation will be submitted when a final specification has been agreed.

Accepted quotations are valid for four months.
